

I have the honor of presenting the 55th Edition of the Primary Election Canvass Book. The May 14, 2024, statewide primary election is the third primary election that has occurred during my tenure as Nebraska's 27th Secretary of State and Chief Elections Officer.

For the first time in Nebraska's history, registered voters in Nebraska were required to cast their ballots after presenting acceptable photo identification. Nebraska's election officials, Nebraska's poll workers and Nebraska's voters successfully implemented and followed the new voting requirement.

In November 2022, Nebraska voters overwhelmingly passed a constitutional amendment requiring photo identification in Nebraska's elections. The Nebraska Legislature enacted legislation implementing the amendment. At the time of the law's passage, at least 97% of registered voters already had an acceptable form of photo ID by having a Nebraska driver's license or state ID.

While presenting a photo ID when voting may seem like a small modification, it required significant changes to voting procedures. The Nebraska Secretary of State's office prepared new training materials for county election officials, created informational material for voters and launched a statewide media campaign including radio, TV, connected TV, social media, direct mailers, billboards and in-person events.

County election officials worked diligently to implement new procedures and to help voters fulfill the voter ID requirement. They answered questions from their voters and spent months conducting their own educational campaigns.

The efforts of the Elections Division, Nebraska's county election officials and poll workers across the state resulted in a successful voter ID implementation. In total, 99.95% of voters who cast a ballot in the Statewide Primary provided an approved photo ID prior to voting. The balance of the ballots were not counted because the voter did not provide an acceptable form of photo ID.

Our office looks forward to continuing these efforts to ensure a successful November general election. Conducting free, fair and secure elections is one of the top priorities of this office, and I am very grateful for the diligent work conducted by our election officials and poll workers who effectively served the people of Nebraska in this election.

Reported Problems

Harlan County

Shortly after early voting ballots were sent out to the by-mail rural Harlan precinct, it was discovered that the 1,301 ballots were not initialed or signed by the county clerk as required by law. The Harlan County Clerk posted an apology and explanation on their website, and impacted voters were sent a replacement ballot with a letter of explanation and instructions. The early voting counting board began opening accepted return envelopes to check for missing initials; it was identified that a total of 184 ballots were returned without the initials. The county clerk's office did additional outreach to these voters, and 137 of the 184 completed a replacement ballot that had initials before the deadline for return of ballots.

The margin in each federal or state contest involving this precinct was greater than 47. As a result, this error did not impact the outcome of the election.

President of the United States

- Partisan Primary:** The Secretary of State must place the names of candidates who are presented by petition of their supporters or who have been determined by the Secretary to be generally advocated or recognized as candidates in national news media. Voters affiliated with a political party receive a ballot that corresponds with their registered political party. For the 2024 primary election, the Democratic, Libertarian, and Legal Marijuana NOW parties allowed nonpartisan voters to request a party ballot containing President. No such nonpartisan voter shall receive more than one such partisan ballot. [§32-614](#), [§32-912](#)
- Term Length:** Four years.
- “Vote For” Number:** Vote for ONE.
- Nomination:** Each political party selects national delegates based on their delegate selection plan to vote in the party’s national convention. The national political party certifies their party’s nominee. [§32-701](#), [§32-712](#)
- Auto-advance Rules:** Contest appears on the primary election ballot regardless of the number of candidates. [§32-811](#)
- Statutory Reference:** [U.S. Const. II-1](#)

Member of the United States Senate

- Partisan Primary:** Candidates file for office by political party. Voters affiliated with a political party receive a ballot that corresponds with their registered political party. Nonpartisan voters may request a party ballot from any party containing United States Senate. No such nonpartisan voter shall receive more than one such partisan ballot. [§32-610](#), [§32-912](#)
- Term Length:** Six years, unless otherwise stated. [§32-565](#)
- “Vote For” Number:** Vote for ONE.
- Nominees per Office:** Top vote-getter per political party.
- Auto-advance Rules:** Contest appears on the primary election ballot regardless of the number of candidates. [§32-811](#)
- Statutory Reference:** [U.S. Const. I-3](#), [US Const. amend. XVII](#), [§32-502](#)

Member of the U.S. House of Representatives

- Partisan Primary:** Candidates file for office by political party. Voters affiliated with a political party receive a ballot that corresponds with their registered political party. 
