#### FINAL LANGUAGE

#### **Hand Count Ballots for Elections Petition**

Object Statement: The object of this petition is a constitutional amendment to require all elections in the State of Nebraska to be conducted exclusively using paper ballots that are counted by hand.

Article VI, section 6, of the Constitution of Nebraska, shall be amended as follows:

- (1) All elections conducted within the State of Nebraska for federal, state, and local offices, and for all ballot measures, shall be conducted exclusively using paper ballots. All votes shall be by paper ballot or by other means authorized by the Legislature whereby the vote and the secrecy of the elector's vote will be preserved.
- (2) Each voter shall be provided with a physical paper ballot to be marked by the voter, and such ballot shall constitute the official record of the voter's intent. Nothing in this section shall be construed to prohibit a voter with a disability from receiving assistance in marking a ballot as provided for by law. Electronic voting machines that do not produce a voter-verifiable paper record shall be prohibited.
- (3) All paper ballots cast in any election in the State of Nebraska shall be counted by hand. Vote counting devices are prohibited. Hand counting shall be conducted in a transparent manner, open to observation by the public and designated election observers, in accordance with procedures established by law to ensure accuracy and prevent fraud.
  - (4) The Legislature shall enact laws to implement this section including laws establishing:
  - (a) Procedures for the design, printing, and secure handling of paper ballots;
  - (b) Procedures for the training and certification of election workers for hand-counting procedures;
- (c) Procedures for the secure storage of and maintenance of a proper chain of custody for all ballots and other election materials;
  - (d) Procedures for the recount and audit of hand-counted ballots; and
  - (e) Penalties for violations of laws enacted pursuant to this section.
  - (5) The changes to this section shall apply to all elections held on or after July 1, 2027.

#### **Proposed Constitutional Amendment Language:**

(underscored language indicates added language, strike through indicates language being removed)

#### Article VI, section 6, of the Constitution of Nebraska, shall be amended as follows:

- (1) All elections conducted within the State of Nebraska for federal, state, and local offices, and for all ballot measures, shall be conducted exclusively using paper ballots. All votes shall be by paper ballot or by other means authorized by the Legislature whereby the vote and the secrecy of the elector's vote will be preserved.
- (2) Each voter shall be provided with a physical paper ballot to be marked by the voter, and such ballot shall constitute the official record of the voter's intent. Nothing in this section shall be construed to prohibit a voter with a disability from receiving assistance in marking a ballot as provided for by law. Electronic voting machines that do not produce a voter-verifiable paper record shall be prohibited.
- (3) All paper ballots cast in any election in the State of Nebraska shall be counted by hand. Vote counting devices are prohibited. Hand counting shall be conducted in a transparent manner, open to observation by the public and designated election observers, in accordance with procedures established by law to ensure accuracy and prevent fraud.
  - (4) The Legislature shall enact laws to implement this section including laws establishing:
  - (a) Procedures for the design, printing, and secure handling of paper ballots;
  - (b) Procedures for the training and certification of election workers for hand-counting procedures;
- (c) Procedures for the secure storage of and maintenance of a proper chain of custody for all ballots and other election materials;
  - (d) Procedures for the recount and audit of hand-counted ballots; and
  - (e) Penalties for violations of laws enacted pursuant to this section.
  - (5) The changes to this section shall apply to all elections held on or after July 1, 2027.
