- 1. The Nebraska State Constitution Article III Section 3 reserves the power for the people to invoke a referendum against any act or part of an act of the Legislature.
- a. If the petition is signed by 5% of the registered voters of the state, the act or part of the act is referred to the electors for approval or rejection at the first general election after filing such petition.
- b. If the petition is signed by 10% of the registered voters of the state, the act or part of act in addition to being placed on the first general election after filing such petition shall not take effect until it has been approved by the electors of the state.
- c. Registered voters signing such petition shall be so distributed as to include 5% of the registered voters of each of two-fifths of the counties (38 out of 93) of the state.
- 2. When submitting petition pages for signature verification, a sponsor of the petition attested to submitting 117,145 signatures. This number is below the 10% threshold (122,615 signatures) to suspend the effect of the law before it is approved by the electors of the state.
- 3. Nebraska Revised Statute §32-1409 allows for the Secretary of State to instruct election commissioners and county clerks to stop verifying signatures if the Secretary of State receives reports from a sufficient number of the counties that an excess of 110% of signatures necessary to place the issue on the ballot have been verified. The results above are not reflective of all signatures submitted.
