## ONLINE NOTARY PUBLIC REGISTRATION INSTRUCTIONS

### APPLICANT INFORMATION:

Name: Enter your legal name for our records. Print name as is listed on your state issued driver's license, identification card, or voter registration name (if no driver's license).

Date: Enter the date you are completing the application.

Home Address: You are required to enter your home street address. If you use a P.O. Box, you may include the P.O. Box in addition to your street address.

Business Address: If you are a non-resident applicant, your business address is required and you must complete this section in its entirety. If you are a Nebraska resident, this section is optional, but if provided, this information may be used to contact you if needed. Your home address and business address can only be the same if you are a Nebraska resident working from home and you check the corresponding box, if not your application may be rejected or returned.

Indicate where you would like your registration returned by checking the appropriate box.

Please note that email addresses submitted on this application become part of the public record.

Non-resident applicants must also complete and submit an Evidence of Employment in Nebraska form.

### ONLINE NOTARY PUBLIC QUALIFICATIONS IN THE STATE OF NEBRASKA:

Please read each section carefully and clearly mark the appropriate box or fill in the details to answer section.

Eligibility to register as an Online Notary requires a notary hold a valid commission in the State of Nebraska, satisfy the educational requirement of section 64-404; pay the fee required under section 64-405. You are not authorized to perform online notarial acts until all requirements are completed and you have received your Online Notary Certificate of Registration.

### REQUIREMENTS:

Applicant must submit the following: Online Notary Registration form, \$50 fee made payable to the Nebraska Secretary of State, and the completed Online Notary Public Exam. You will be required to take the training course at a later time, within 30 days after it is made available by the Secretary of State.
