INSTRUCTIONS

1. The report is blank and must be completed with the latest information on record. You may change the names and addresses of the officers and directors, the street address of the principal office, or the nature of business.

Public Benefit, Mutual Benefit and Religious Corporation designation:

- a. All nonprofit corporations are required to state whether they are a public benefit corporation, mutual benefit corporation, or religious corporation in their Articles of Incorporation (see Neb. Rev. Stat. § 21-1921). Please review your Articles of Incorporation if you are unsure of what designation to select.
- b. If your corporation was in existence before January 1, 1997 and became subject to the Nebraska Nonprofit Corporation Act please review the following definitions to determine what designation to select.
 - Religious corporation: Any corporation organized primarily or exclusively for religious purposes.
 - Public benefit corporation: Any corporation recognized as exempt under section 501(c)(3) of the Internal Revenue Code or any corporation organized for a public or charitable purpose, and upon dissolution must distribute its assets to a public benefit corporation, the United States, a state, or a person recognized as exempt under section 501(c)(3) of the Internal Revenue Code.
 - Mutual benefit corporation: Any corporation that does not come within the above definitions.

Member definition: Any person or persons who, on more than one occasion, have the right to vote for the election of a director or directors.

2. Changes to the corporate type (public benefit, mutual benefit, or religious corporation) and whether or not the corporation has members are allowed on this form. Note: the information given must match the corporation's Articles of Incorporation or the latest Amendment or Certificate of Authority or latest Amendment in the case of a foreign nonprofit corporation.

6. The biennial filing fee is \$30.00 and the reinstatement filing fee is \$30.00 for a total of \$60.00 due. Make checks payable to "Secretary of State." Make a copy of the completed forms and retain it for your records.
