




32-614 The Nebraska Secretary of State makes a determination on who is a generally advocated or recognized candidate in the national news media throughout the United States. President and Vice-President shall be elected in 2000, 2004, 2008, 2012.

32-502 Two United States Senators elected statewide – Partisan Ballot – 6 year terms One senator shall be elected in 1994, 2000, 2006, 2012 One senator shall be elected in 1996, 2002, 2008, 2014






Districts 1, 2, 3 Elect every even-numbered year

Public Service Commission - LB 855 (2001)



Districts 2	Elect 1996, 2002, 2008, 2014
Districts 4 & 5	Elect 1992, 1998, 2004, 2010

University of Nebraska Board of Regents - LB 854 (2001) (Districts take effect June 1, 2001)




32-510 The state is divided into 8 districts – Non-partisan Ballot – 6 year terms

Districts 3 & 4	Elect 1994, 2000, 2006, 2012
Districts 5 & 8	Elect 1994, 2000, 2006, 2012
Districts 6 & 7	Elect 1998, 2004, 2010, 2016


State Board of Education - LB 856 (2001)

(Districts take effect June 1, 2001)



32-511 The state is divided into 8 districts – Non-partisan Ballot – 4 year terms

Districts 1, 2, 3, 4	Elect 2000, 2004, 200	<mark>8,</mark> 2012
Districts 5, 6, 7, 8	Elect 1998, 2002, 200	6, 2010



32-508 The state is divided into 49 districts – Non-partisan ballot – 4 year terms

Even-numbered districts elect in 1994, 1998, 2002, 2006, 2010 Odd-numbered districts elect in 1996, 2000, 2004, 2008, 2012

Copies of certifications from the subdivisions that are a part of any county will be mailed to the county official by the subdivision. If counties do not receive a copy of the certification shortly after the January 7<sup>th</sup> deadline, contact the subdivision office and then the Secretary of State's Office.

Copies of certifications from the subdivisions that are a part of any county will be mailed to the county official by the subdivision.


Educational Service Units – Non-Partisan Odd numbered districts – two year terms Even numbered districts – 4 year terms

Learning Community Coordinating Council – Non-Partisan Odd numbered districts – two year terms Even numbered districts – 4 year terms

Reclamation Districts - Non Partisan - 6 years

Public Power (& Irrigation) Districts, grossing less than \$40 million annually Non Partisan - 6 year terms

Nebraska Supreme Court Judicial Districts - LB 853 (2001) (Districts take effect June 1, 2001)



Chapter 24 divides the state into 6 judicial districts. Judges must file Retention Requests with the Secretary of State's Office by the August 1<sup>st</sup> immediately preceding the expiration of their 6-year term of office. These will be certified to the County Clerk or Election Commissioner by the Secretary of State's Office to be placed on the General Election ballot.
