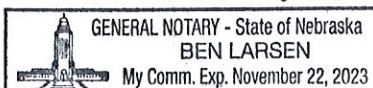

Granting Governor Overrule Authority

The object of this petition is to:

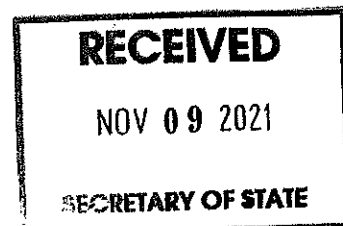
Grant the Governor of Nebraska the authority to overrule rules, laws, and regulations of political subdivisions.

Article IV of the Constitution of Nebraska shall be amended by adding a new section 29 as shown:

The Governor shall have authority, through the issuing of one or more executive orders, to overrule rules, laws, and regulations of any and all political subdivisions or independent governmental agencies within the state of Nebraska.

The overruling executive orders issued by the governor may be overridden by a three/fifths supermajority of the Legislature.

This amendment becomes operative on January 11, 2023.

To the Honorable Robert Evnen, Secretary of State for the State of Nebraska:

We, the undersigned residents of the State of Nebraska and the county of _____, respectfully demand that the following proposed amendment to the Constitution of Nebraska shall be referred to the registered voters of the state for their approval or rejection at the general election to be held on the 8th day of November 2022, and each for himself or herself says: I have personally signed this petition on the date opposite my name; I am a registered voter of the State of Nebraska and county of _____ and am qualified to sign this petition or I will be so registered and qualified on or before the date on which this petition is required to be filed with the Secretary of State; and my printed name, date of birth, street and number or voting precinct, and city, village, or post office address are correctly written after my signature.

WARNING TO PETITION SIGNERS-- VIOLATION OF ANY OF THE FOLLOWING PROVISIONS OF LAW MAY RESULT IN THE FILING OF CRIMINAL CHARGES: Any person who signs any name other than his or her own to any petition or who is not qualified to sign the petition shall be guilty of a Class I misdemeanor. Any person who falsely swears to a circulator’s affidavit on a petition, who accepts money or other things of value for signing a petition, or who offers money or other things of value in exchange for a signature upon any petition shall be guilty of a Class IV felony.

Proposed Constitutional Amendment Language:

Article IV of the Constitution of Nebraska shall be amended by adding a new section 29 as shown:

The Governor shall have authority, through the issuing of one or more executive orders, to overrule rules, laws, and regulations of any and all political subdivisions or independent governmental agencies within the state of Nebraska.

The overruling executive orders issued by the governor may be overridden by a three/fifths supermajority of the Legislature.
